

ENROLLED ORDINANCE 159-95

ESTABLISHMENT OF SPEED ZONE – CTH K
VILLAGE OF BUTLER
TWENTY-FIVE MILES PER HOUR

WHEREAS Wisconsin Statutes permit local authorities to establish speed zones within certain guidelines.

THE COUNTY BOARD OF SUPERVISORS OF THE COUNTY OF WAUKESHA DOES ORDAIN that the speed zone on CTH K in the Village of Butler is modified as follows:

Twenty-five (25) miles per hour on CTH K from a point 200 feet easterly of its intersection with 134th street easterly to its intersection with 124th Street.

BE IT FURTHER ORDAINED that this declaration rescinds all previous restrictions for the above described portion of the County Trunk Highway System.
