

ENROLLED ORDINANCE 160-16

ESTABLISHING DONATION FUNDED ACCOUNTS AND APPROPRIATING FUNDS
IN THE COUNTY EXECUTIVE BUDGET TO ACCOUNT FOR AND PAY
ENTERTAINMENT COSTS FOR VISITORS OF SISTER
CITY / COUNTY COUNTRIES

WHEREAS, Waukesha County has established a sister county partnership with Offenbach County of the Federal Republic of Germany, and

WHEREAS, as part of the promotion to the sister county partnership, a Youth camp has been established with Offenbach County and other countries with a sister city county relationship, and

WHEREAS, Waukesha County will be one of the local Youth Camp hosts in July, 2005 with participation expected from China, Turkey, and Poland as well as Germany, and

WHEREAS, donations will be solicited to fully fund entertainment expenses associated with the Youth Camp and visitation, and


WHEREAS, accounts for donation revenue and expenditure authority not to exceed revenues needs to be established to accommodate certain youth camp and visitation activities.


THE COUNTY BOARD OF SUPERVISORS OF THE COUNTY OF WAUKESHA DOES ORDAIN that the County Executive be authorized to accept donations to fund expenses associated with the Sister City/County Youth Camp and visitation hosted by Waukesha County in 2005.

BE IT FURTHER ORDAINED that the 2005 County Executive budget be modified by appropriating \$15,000 to the County Executive Special Programs expense account, with expenditure authority not to exceed the donations received in connection this program and that the general donations account in the same budget be increased by \$15,000.


