

ENROLLED ORDINANCE 160-21

ESTABLISH SALARY FOR COUNTY BOARD CHAIRPERSON

WHEREAS the Waukesha County Code of Ordinances states that the County Board Chairperson shall receive a salary as determined by the County Board, and

WHEREAS Enrolled Ordinance 151-105, adopted on February 25, 1997, indicated that prospective salaries for elected officials should be established on a rational basis by approximating cost-of-living adjustments received by county employees in prior years for comparable periods, and

WHEREAS non-represented employees received across-the-board increases as follows: 3.0% in 2002, 2.8% in 2003, 1.75% in 2004 and 2.75% in 2005, and

WHEREAS, comparable to increases for non-represented employees, the salary for the County Board Chairperson should be adjusted accordingly.

THE COUNTY BOARD OF SUPERVISORS OF THE COUNTY OF WAUKESHA DOES ORDAIN that the salary for the County Board Chairperson shall be as follows:

1. Effective the first pay period following the third Tuesday in April 2006, the salary for the County Board Chairperson shall be increased from \$2,031.58 bi-weekly (\$52,821 annually) to \$2,067.12 bi-weekly (\$53,745 annually).
2. Effective the first pay period following the third Tuesday in April 2007, the salary for the County Board Chairperson shall be increased from \$2,067.12 bi-weekly (\$53,745 annually) to \$2,123.96 bi-weekly (\$55,223 annually).
