

ENROLLED ORDINANCE 161-54

APPROPRIATE EXPENDITURES AND INCREASE REVENUE FOR MUNICIPAL  
AMENITIES INCLUDED IN CAPITAL PROJECT 9706  
CTH L, MOORLAND ROAD TO EAST COUNTY LINE

WHEREAS the County owns and operates a system of county trunk highways, and

WHEREAS from time to time the County undertakes projects to reconstruct and improve said highways, and

WHEREAS as part of a project agreement with the City of Muskego, amenities including recreational trails, streetscaping and street lights were constructed as part of this project, the costs of such to be reimbursed by the City, and

WHEREAS funds have been received from The City of Muskego as reimbursement for items requested by the city, and

WHEREAS additional funds are needed for CTH L, Moorland Road to East County line, (Capital Project 9706).

THE COUNTY BOARD OF SUPERVISORS OF THE COUNTY OF WAUKESHA DOES ORDAIN that Capital Project 9706 (CTH L) be amended to increase expenditure appropriations by \$350,000 for additional costs for municipal roadway amenities, and

BE IT FURTHER ORDAINED that capital project revenue be increased by \$350,000 for reimbursement of costs for roadway amenities from the City of Muskego.
