

ENROLLED ORDINANCE 161-60

AMEND THE WAUKESHA COUNTY CODE TO ADD TWO INDIVIDUALS TO THE
MEMBERSHIP OF THE CRIMINAL JUSTICE COLLABORATING COUNCIL

WHEREAS the Criminal Justice Collaborating Council was originally created by Enrolled Ordinance 157-O-068 to be comprised of eleven members, and

WHEREAS the Council has determined that it would be in its best interests, in order to more expeditiously meet its goals and objectives, to increase its membership by two individuals, and

WHEREAS the two new members will be: a University of Wisconsin Extension Representative and a Waukesha County Citizen.

THE COUNTY BOARD OF SUPERVISORS OF THE COUNTY OF WAUKESHA DOES
ORDAIN that:

SECTION 1. Chapter 4, Section 4-212(b) of the Waukesha County Code pertaining to the Criminal Justice Collaborating Council is repealed and recreated to read as follows:

The Criminal Justice Collaborating Council shall consist of the following members:

1. Chief Judge or Presiding Judge for Waukesha County
2. County Executive
3. County Board Chair
4. Sheriff
5. District Attorney
6. Clerk of Circuit Court
7. Mayor of City of Waukesha
8. First Assistant Public Defender - Waukesha County
9. Waukesha County Police Chief Association Representative
10. Director of Health & Human Services
11. Parole and Probation Manager responsible for Waukesha
12. University of Wisconsin Extension Representative
13. Waukesha County Citizen

SECTION 2. This ordinance shall be effective upon approval and publication.

SECTION 3. The provisions of this ordinance shall be included and incorporated in the Code of Ordinances of the County of Waukesha, Wisconsin, as an addition or amendment thereto and shall be appropriately renumbered to conform to the numbering system contained therein.

SECTION 4. Any code section or part of a section in conflict with this ordinance is hereby repealed and declared null and void and of no effect.
