

ENROLLED ORDINANCE 161-68

APPROVE PARTNERSHIP AGREEMENT WITH OZAUKEE COUNTY
FOR SHARED EMERGENCY MANAGEMENT COORDINATOR

WHEREAS, Waukesha County employs a full-time emergency manager in its Department of Emergency Preparedness, and

WHEREAS, Ozaukee County has need for part-time services of an emergency manager, and

WHEREAS, Wisconsin Statutes §66.0301 and §166.03(7) (a)-(c) allow counties to contract with another political subdivision, emergency management unit and civil defense unit of this state to furnish services, combine offices and finance emergency management services, and

WHEREAS, sharing the services of an Emergency Manager will reduce duplicitous activities, facilitate coordinated responses to regional emergency situations, maximize grant funding opportunities for both counties, provide \$36,500 of contract revenues to Waukesha County to cover costs associated with the shared services agreement and will be otherwise beneficial to each county.

THE COUNTY BOARD OF SUPERVISORS OF THE COUNTY OF WAUKESHA ORDAINS that the contract with Ozaukee County to share the Emergency Management Coordinator position is hereby approved.

BE IT FURTHER ORDAINED that effective January 6, 2007 the following reclassification be accomplished by abolishing one regular full time position of Clerk Typist I/II, 2006 hourly salary range \$11.8754 - \$14.4895, and creating one regular full time position of Program Assistant, 2006 hourly salary range \$13.8935 - \$16.2223 in the Department of Emergency Preparedness to meet the needs of Waukesha County while the Emergency Management Coordinator is working with both counties.

BE IT FURTHER ORDAINED, the sunset clause attached to the Clerk Typist I/II position is extended to the newly created Program Assistant position if the contract for services ends with Ozaukee County, the Personnel Committee will review this position and determine the appropriate classification.


BE IT FURTHER ORDAINED, that the 2007 adopted Emergency Preparedness Department-Emergency Management Program budget be modified to increase Charges for Services revenues by \$13,100 and to increase personnel costs \$1,300, operating expenses \$8,800 and interdepartmental \$3,000 to cover additional budgeted costs associated with providing shared Emergency Management Coordinator services to Ozaukee County.


