ACCEPT 2008 STATE OF WISCONSIN DEPARTMENT OF TRANSPORTATION TRACS
PROJECT GRANT AND MODIFY WAUKESHA COUNTY SHERIFF DEPARTMENT'S
2008 BUDGET TO AUTHORIZE GRANT EXPENDITURES

WHEREAS, the State of Wisconsin Department of Transportation made grant funds available to counties to fund development of interfaces between local automated records management systems and the state's Traffic and Criminal Software (TraCS) system that provides automated citation and accident information and reporting, and

WHEREAS, these grant funds became available after the 2008 budget process had been completed, and

WHEREAS, this grant will be used to increase the effectiveness of the TraCS system by allowing the responses to user mobile data computer information requests to be automatically transferred to the TraCS software, and

WHEREAS, grant funds are available only to a consortium of police agencies; they are not available to a single agency.

THE COUNTY BOARD OF SUPERVISORS OF THE COUNTY OF WAUKESHA ORDAINS that the Waukesha County Sheriff's Department be authorized to accept a Wisconsin Department of Transportation grant of \$10,370 to fund the purchase and implementation of interface software to transfer user mobile data computer request information directly to TraCS system.

BE IT FURTHER ORDAINED that the Sheriff's Department 2008 budget be modified by increasing intergovernmental revenues by \$10,370, and increasing the department's operating expenditure appropriation unit by \$10,370 to cover costs associated with the project.
