ESTABLISHMENT OF SPEED ZONE - CTH Y

WHEREAS Wisconsin Statutes permit local authorities to establish speed zones within certain guidelines.

THE COUNTY BOARD OF SUPERVISORS OF THE COUNTY OF WAUKESHA DOES ORDAIN that the speed zone on CTH Y in the City of Muskego is modified as follows:


Forty-five (45) miles per hour on CTH Y from a point 0.6 miles North of the Racine County Line northerly to a point 1500 feet north of its intersection with Kelsey Road.


BE IT FURTHER ORDAINED that this declaration rescinds all previous restrictions for the above-described portion of the County Trunk Highway System.


Kelse Road
