

ENROLLED ORDINANCE 162-40

ASHIPPUN LAKE ACCESS IMPROVEMENT

WHEREAS the Waukesha County Board of Supervisors on May 26,1967, agreed to lease 20 acres for Lake Ashippun access from the State of Wisconsin for an indefinite time to provide residents, fisherman, recreational boaters and hunters year round access to Ashippun Lake, and

WHEREAS the original concrete plank construction at the Lake Ashippun access site, completed in 1967, has now deteriorated to less than desirable conditions, and

WHEREAS the cost for lake access improvements are estimated to be \$44,451, and

WHEREAS the Waukesha County Conservation Alliance has agreed to donate \$10,000 towards lake access improvements, and

WHEREAS the Waukesha County Department of Parks and Land Use can apply to the State of Wisconsin Department of Natural Resources for Lake Access Grant Funds to provide up to 50% of the total cost of improvements or a maximum of \$22,225 for project funding, and

WHEREAS the Waukesha County Department of Parks and Land Use has designated \$12,300 in facility maintenance funding for Ashippun Lake access improvements.

THE COUNTY BOARD OF SUPERVISORS OF THE COUNTY OF WAUKESHA DOES ORDAIN that the Waukesha County Department of Parks and Land Use be authorized to accept the donation of funds from the Waukesha County Conservation Alliance for use toward the Ashippun Lake access improvements.




BE IT FURTHER ORDAINED that the Department's Year 2007 budget be amended to increase the appropriate expenditure and revenue accounts by \$32,225.






