TO CTH I, CITY OF NEW BERLIN, WAUKESHA COUNTY


WHEREAS the County Board of Supervisors of Waukesha County finds that the proper improvement in maintenance of the above County Trunk Highway in the City of New Berlin, Waukesha County from a point that is 573.07 feet south of and 89.00 feet west of the center of Section 32, Town 6 North, Range 20 East, City of New Berlin, Waukesha County to a point that is 1,603.08 feet north of and 336.94 feet west of the South one-quarter corner of Section 20, Town 6 North, Range 20 East, City of New Berlin, requires certain relocation or changes and the acquisition of certain rights of way as shown on the plat marked "Plat of Right of Way Required for CTH Y, Project I.D. 04-2779(13)(A), CTH Y, I-43 to CTH I, Waukesha County".






