

ENROLLED ORDINANCE 162-93

ADJUSTMENT OF SALARY FOR ELECTRICIAN AND TELECOMMUNICATOR

WHEREAS the Department of Public Works – Facilities Management Division employs an electrician on a full-time basis to provide, repair and maintenance of electrical systems in County facilities, and

WHEREAS it has been determined that it is more cost effective to employ a full-time employee rather than outsource the work, and

WHEREAS the County's current salary for electrician does not allow us to compete in the labor market in order to hire a qualified electrician, and

WHEREAS in the 2008 budget the Department of Emergency Preparedness has unfunded a Telecommunicator Supervisor position, and

WHEREAS the Department has created a program which will enable a Telecommunicator to assume a limited supervisory role in charge of a shift or portion of a shift, when a supervisor is absent or unavailable, and

WHEREAS a similar provision is in place for Correctional Officers in the County Jail.

THE COUNTY BOARD OF SUPERVISORS OF THE COUNTY OF WAUKESHA DOES ORDAIN that the salary range for the Electrician be modified with a salary adjustment of \$5.50 per hour.

BE IT FURTHER ORDAINED that when a Telecommunicator is assigned to act as an officer in charge in the absence of a supervisor, the employee shall receive an additional \$1.00 per hour for the hours performing this function.
