

ENROLLED ORDINANCE 163-104

ACCEPT 2009 JOINT FEDERAL JUSTICE ASSISTANCE GRANT AND  
MODIFY WAUKESHA COUNTY SHERIFF DEPARTMENT'S 2009  
BUDGET TO AUTHORIZE GRANT EXPENDITURES

WHEREAS, the federal Edward Byrne Justice Assistance Grant program (JAG) has made grant funds available to the Waukesha County Sheriff's Department in partnership with the City of Waukesha Police Department, and

WHEREAS, these grant funds became available after the 2009 budget process was completed, and

WHEREAS, the Sheriff's Department has identified uses for this funding for additional equipment to allow completion of a state grant for audio/visual equipment at both the Justice Addition and Sussex sub-station, and

WHEREAS, funds from this grant will also be used to provide matching funds for five years maintenance on equipment to be used by the Department's Computer Forensics unit to enable analysis of cell phone computer records under a separate grant currently being applied for, and

WHEREAS, the balance of the grant will be used to purchase a replacement fax machine and computer software to allow the department to issue checks utilizing a computer instead of a typewriter.

THE COUNTY BOARD OF SUPERVISORS OF THE COUNTY OF WAUKESHA ORDAINS that the Waukesha County Sheriff's Department 2009 Budget be modified by an amount not to exceed \$9,519 and authorize the appropriation of an identical amount in its Operating Expense appropriations based on actual expenditures made in accordance with the Edward Byrne Justice Assistance Grant program grant authorizations.

BE IT FURTHER ORDAINED that the modifications to the 2009 budget appropriations authorized by this ordinance shall be made by the county's Department of Administration upon presentation of proper documentation by the Sheriff's Department as the exact expenses are identified, not to exceed a total of \$9,519.
