

ENROLLED ORDINANCE 163-41

AUTHORIZE EMERGENCY VEHICLE DESIGNATION FOR
DEPARTMENT OF EMERGENCY PREPAREDNESS VEHICLES

WHEREAS, the Waukesha County Office of Emergency Management, Department of Emergency Preparedness must respond to a variety of emergency situations throughout Waukesha County, and

WHEREAS, the Office of Emergency Management obtained a vehicle through Urban Area Security Grant funds to transport personnel and equipment to emergency situations, and

WHEREAS, heavy traffic can obstruct and significantly delay the arrival of critical resources to the emergency, and

WHEREAS, once arriving at the emergency incident it may be necessary to stop, stand or park the vehicle in an area prohibited for most vehicles, and

WHEREAS, a designation as an emergency vehicle under Wisconsin Statute sec. 346.03 would provide exemptions to most traffic laws and thus allow the vehicle to more easily respond to emergencies.


THE COUNTY BOARD OF SUPERVISORS OF THE COUNTY OF WAUKESHA ORDAINS that vehicles assigned to the Department of Emergency Preparedness, Office of Emergency Management are designated as authorized emergency vehicles as defined by section 340.01, Wisconsin Statutes, and granted the privileges afforded under section 346.03, Wisconsin Statutes when operated and equipped in strict accordance with Wisconsin Statute Chapters 346 and 347 as they relate to authorized emergency vehicles.


