LAYING OUT, RELOCATION AND IMPROVEMENT OF COUNTY TRUNK HIGHWAY Y,  
WAUKESHA COUNTY PROJECT, PROJECT I.D. 04-2779(13)(A), CTH Y – I-43 to CTH I  
CITY OF NEW BERLIN, WAUKESHA COUNTY

WHEREAS the County Board of Supervisors of Waukesha County finds that the proper improvement in maintenance of County Trunk Highway Y in the City of New Berlin, Waukesha County from a point that is 573.07 feet south of and 89.00 feet west of the center of Section 32, Town 6 North, Range 20 East, City of New Berlin, Waukesha County to a point that is 132.87 feet South of the South line of Section 20, Town 6 North, Range 20 East, City of New Berlin, requires certain relocation or changes and the acquisition of certain rights of way as shown on the plat marked "Plat of Right of Way Required for CTH Y, Project I.D. 04-2779(13)(A), CTH Y, I-43 to CTH I, Waukesha County."


