LAYING OUT, RELOCATION AND IMPROVEMENT OF COUNTY TRUNK HIGHWAY L,
WAUKESHA COUNTY PROJECT, PROJECT I.D. 06-2380(13), CTH Y TO CTH O,
CITY MUSKEGO, WAUKESHA COUNTY

WHEREAS the County Board of Supervisors of Waukesha County finds that the proper improvement in maintenance of County Trunk Highway L in the City of Muskego from a point that is 76.413 feet north of and 55.481 feet east of the Southwest corner of the Southwest one-quarter of Section 9, Town 5 North, Range 20 East, City of Muskego, Waukesha County, State of Wisconsin to a point that is 930.093 feet South of and 21.039 feet East of the Center of Section 9, Town 5 North, Range 20 East, City of Muskego, Waukesha County, State of Wisconsin, requires certain relocation or changes and the acquisition of certain rights of way as shown on the plat marked "Plat of Right of Way Required for CTH L, Project I.D. 06-2380(13), CTH L, CTH Y to CTH O, Waukesha County," and


WHEREAS, the plat is on file in the office of the Waukesha County Clerk.

THE COUNTY BOARD OF SUPERVISORS OF THE COUNTY OF WAUKESHA DOES ORDAIN that County Trunk Highway L in the City of Muskego is hereby changed or relocated from a point that is 76.413 feet north of and 55.481 feet east of the Southwest corner of the Southwest one-quarter of Section 9, Town 5 North, Range 20 East, City of Muskego, Waukesha County, State of Wisconsin to a point that is 930.093 feet South of and 21.039 feet East of the Center of Section 9, Town 5 North, Range 20 East, City of Muskego, Waukesha County, State of Wisconsin, and that the County shall acquire certain rights of way as shown on the plat marked "Plat of Right of Way Required for CTH L, Project I.D. 06-2380(13), CTH L, CTH Y to CTH O, Waukesha County."

BE IT FURTHER ORDAINED that said plat is adopted by reference under the authority granted by Section 83.08 and Chapter 32 of the Wisconsin Statutes.




