

ENROLLED ORDINANCE 163-5

ACCEPT HOMELAND SECURITY-URBAN AREA SECURITY INITIATIVE FY2006
PROGRAM FUNDING AND MODIFY THE EMERGENCY PREPAREDNESS 2008
BUDGET TO APPROPRIATE GRANT REVENUES AND EXPENDITURES
FOR A TRIAGE TRAILER AND PRIME MOVER

WHEREAS, the United States Department of Homeland Security designated Waukesha County, along with the City of Milwaukee, Milwaukee, Ozaukee, Racine and Washington Counties as an Urban Area eligible for grant funding to enhance the capabilities to prevent, respond to, and recover from acts of terrorism, and

WHEREAS, federal fiscal year 2006 Homeland Security-Urban Area Security Initiative (UASI) grant funding is available to the Urban Area agencies, and

WHEREAS, the Milwaukee UASI included a funding request for Waukesha County to purchase a triage trailer and prime mover to better prepare Waukesha County and the entire region should a mass casualty event occur, and

WHEREAS, the triage trailer will have emergency medical supplies and equipment to assist with mass casualty response, and

WHEREAS, Waukesha County and the City of Waukesha have developed a Memorandum of Understanding which is on file in the Office of Emergency Management that states that Waukesha County will be responsible for the prime mover and that the City of Waukesha will be responsible for the triage trailer, and

WHEREAS, Waukesha County and the State of Wisconsin have developed a Memorandum of Understanding which is on file in the Office of Emergency Management that indicates in case a mass casualty event occurs outside the County, the State could request to use this equipment, and


WHEREAS, the United States Department of Homeland Security and the Wisconsin Office of Justice Assistance approved the investment justifications, allocated funding and authorized Waukesha County to submit grant applications for these projects.

THE COUNTY BOARD OF SUPERVISORS OF WAUKESHA COUNTY DOES ORDAIN that the Waukesha County Emergency Preparedness Department-Emergency Management Office be authorized to accept \$121,000 of Federal Homeland Security grant funding.


BE IT FURTHER ORDAINED that the Emergency Preparedness 2008 budget be modified by increasing Intergovernmental Grant revenue appropriation \$121,000, and increasing Operating expense appropriations by \$65,864 and Fixed asset appropriations by \$55,136.


