

ENROLLED ORDINANCE 163-55

AMEND THE WAUKESHA COUNTY SHORELAND AND FLOODLAND PROTECTION  
ORDINANCE BY AMENDING VARIOUS SECTIONS PERTAINING TO THE  
REGULATION OF FLOODPLAINS (SZ-1680)

WHEREAS, the Waukesha County Board of Supervisors enacted the Waukesha County Shoreland and Floodland Protection Ordinance on January 23, 1970; and,

WHEREAS, the Waukesha County Board of Supervisors may make amendments to such Ordinance pursuant to Section 59.69, Wisconsin Statutes; and,

WHEREAS, the Federal Emergency Management Agency (FEMA) has revised and issued new Flood Insurance Rate Maps (FIRM), as part of a map modernization program throughout the Country and has prepared said maps for adoption by Waukesha County no later than November 19, 2008; and,

WHEREAS, the floodplain provisions of the Waukesha County Shoreland and Floodland Protection Ordinance need to be updated and amended to be compliant with Chapter NR 116 of the Wisconsin Administrative Code and the minimum standards of 44 CFR 60 of the Federal Register administered by FEMA. The amendments must be adopted by the Waukesha County Board of Supervisors by November 19, 2008, in order to maintain eligibility under the National Flood Insurance Program administered by FEMA; and,

WHEREAS, a public open house and hearing was held on March 6, 2007, at the Waukesha County Exposition Center and a formal public hearing was held pursuant to the amendment requirements of the Waukesha County Shoreland and Floodland Protection Ordinance on September 24, 2008, at the Waukesha County Courthouse on the final FIRM maps from FEMA and amendments to the text of the Waukesha County Shoreland and Floodland Protection Ordinance; and,

WHEREAS, the Waukesha County Park and Planning Commission on October 1, 2008, has reviewed and recommended in favor of the adoption of the new FIRM maps and aforementioned text amendments and has forwarded the proposed amendments and the FIRM maps, along with a "Staff Report and Recommendation" to the Land Use Parks and Environment Committee and the Waukesha County Board of Supervisors with its recommendation for approval.

THE COUNTY BOARD OF SUPERVISORS OF THE COUNTY OF WAUKESHA ORDAINS that the text of the Waukesha County Shoreland and Floodland Protection Ordinance is hereby amended in accordance with the 2008 floodplain amendments adopted by the Land Use, Parks and Environment Committee and on file in the Department of Parks and Land Use and the Waukesha County Clerk.

BE IT FURTHER ORDAINED that this text amendment includes the adoption of a number of the Flood Insurance Rate Maps (FIRM) maps for floodplains as referenced in Section 6(b)1.B., entitled "Official Maps: Based on the Flood Insurance Study" for Waukesha County with an effective date of November 19, 2008 and the FIRM maps are hereby adopted.

BE IT FURTHER ORDAINED that this ordinance shall be effective upon approval and publication.




BE IT FURTHER ORDAINED that any section or part of a section in conflict with this ordinance is hereby repealed and declared null and void and of no effect.






