FIRST REVISION TO LAYING OUT, RELOCATION AND IMPROVEMENT OF
COUNTY TRUNK HIGHWAY Y, WAUKESHA COUNTY PROJECT –
PROJECT I.D. 08-2779(15) – KELSEY ROAD INTERSECTION,
CITY OF MUSKEGO, WAUKESHA COUNTY

WHEREAS the County Board of Supervisors of Waukesha County finds that the proper improvement in maintenance of the above County Trunk Highway in the City of Muskego from a point located at the Center of Section 32, Town 5 North, Range 20 East, City of Muskego to a point that is located at the Center of Section 29, Town 5 North, Range 20 East, City of Muskego, requires certain relocation or changes and the acquisition of certain rights of way as shown on the plat marked "Plat of Right of Way Required for CTH Y, Project I.D. 08-2779(15), CTH Y, Kelsey Road Intersection, Waukesha County".


