

ENROLLED ORDINANCE 163-84

REPEAL AND RECREATE SECTION 15-2 OF THE WAUKESHA COUNTY CODE OF ORDINANCES REGARDING THE ESTABLISHMENT OF FEES FOR THE WAUKESHA COUNTY DEPARTMENT OF PUBLIC WORKS

WHEREAS the Waukesha County Department of Public Works bi-annually sets fees for Right of Way permits, and

WHEREAS section 15-2 of the Waukesha County Code of Ordinances sets out the fees for right of way permits and studies, and

WHEREAS these fees are set in the county budget, and then the Code of Ordinances must be changed by ordinance as well to allow the fees to be charged.

THE COUNTY BOARD OF SUPERVISORS OF THE COUNTY OF WAUKESHA DOES ORDAIN that

Section 1. Section 15-2 of the Waukesha County Code of Ordinances is repealed and recreated to read as follows:

Fees for Right of Way permits shall be specifically identified in the budget book document during the annual budget process and shall be on file in the Office of the Director of Public Works.

Section 2. This ordinance shall be effective January 1, 2010.


Section 3. The provisions of this ordinance shall be included and incorporated in the Code of Ordinances of the County of Waukesha, Wisconsin, as an addition or amendment thereto and shall be appropriately renumbered to conform to the numbering system contained therein.

Section 4. Any code section or part of a section in conflict with this ordinance is hereby repealed and declared null and void and of no effect.
