

ENROLLED ORDINANCE 163-92

ACCEPT HOMELAND SECURITY –TRAINING PROGRAM FUNDING AND MODIFY
THE EMERGENCY PREPAREDNESS 2009 BUDGET TO APPROPRIATE
GRANT REVENUES AND EXPENDITURES

WHEREAS, the County Emergency Management division is the coordinator of disaster incident preparation and response in Waukesha County, and

WHEREAS, activating and operating an Emergency Operations Center (EOC) and using the Incident Command System (ICS) are integral components of effective disaster preparation and response, and

WHEREAS, Wisconsin Emergency Management has allocated \$4,270 to Waukesha County to conduct an Emergency Operations Course and an ICS/EOC Interface course to ensure personnel are properly trained to perform the functions required of them while assigned to the EOC and to effectively work with an ICS position in the field, and


WHEREAS, Waukesha County's funding application was submitted and approved for \$4,270 for these training courses to be held in 2009.

THE COUNTY BOARD OF SUPERVISORS OF WAUKESHA COUNTY DOES ORDAIN that Waukesha County Emergency Management Office is authorized to accept \$4,270 of grant funding through Wisconsin Emergency Management.


