PURSUE REINSTATEMENT OF TRANSIT SERVICE TO THE UNIVERSITY  
OF WISCONSIN MILWAUKEE IN THE 2009 BUDGET

WHEREAS the Waukesha County transit system is managed by Waukesha Metro Transit through a contract with the City of Waukesha, and

WHEREAS the transit service is operated by various transit contractors including but not limited to Wisconsin Coach Lines, and

WHEREAS the 2009 Adopted Budget narrative indicates the direct service to the University of Wisconsin – Milwaukee extension of a route operated by Wisconsin Coach Lines would be terminated in January, 2009, and


WHEREAS discussions between Waukesha Metro Transit, Wisconsin Coach Lines and Waukesha County have resulted in reasonable analysis that the service to the University of Wisconsin – Milwaukee can be continued during the academic year with farebox and State transit revenue without further levy contribution by the county, and

WHEREAS the effectiveness of the service and available non-levy funding will be evaluated at the end of the Spring 2009 semester to determine whether the service will be continued in the Fall of 2009.


THE COUNTY BOARD OF SUPERVISORS OF THE COUNTY OF WAUKESHA




