

ENROLLED ORDINANCE 164-19

ACCEPT HOMELAND SECURITY-URBAN AREA SECURITY INITIATIVE FY2008
PROGRAM FUNDING AND MODIFY THE EMERGENCY PREPAREDNESS 2009
BUDGET TO APPROPRIATE GRANT REVENUES AND EXPENDITURES
FOR RESPIRATORY FIT TESTING EQUIPMENT

WHEREAS, the United States Department of Homeland Security designated Waukesha County, along with the City of Milwaukee, Milwaukee, Ozaukee, Racine and Washington Counties as an Urban Area eligible for grant funding to enhance the capabilities to prevent, respond to, and recover from acts of terrorism and other all hazard events, and

WHEREAS, federal fiscal year 2008 Homeland Security-Urban Area Security Initiative (UASI) grant funding is available to the Urban Area agencies, and

WHEREAS, the Milwaukee UASI included a funding request to purchase respiratory fit testing equipment in order to perform annual face piece fit testing of first responders for agencies within the County as required by federal Occupational Safety and Health Administration as well as the State of Wisconsin, and

WHEREAS, the United States Department of Homeland Security and the Wisconsin Office of Justice Assistance approved the investment justifications, allocated funding, authorized Waukesha County to submit a grant application, and issued a grant award to fund the purchase of equipment to perform annual respiratory face piece fit testing for first responders.

THE COUNTY BOARD OF SUPERVISORS OF WAUKESHA COUNTY ORDAINS that the Waukesha County Emergency Preparedness Department-Emergency Management Office be authorized to accept \$14,804 of Federal Homeland Security grant funding.




