

ENROLLED ORDINANCE 166-77

ESTABLISHMENT OF SPEED ZONE ON C.T.H. E
IN TOWN OF MERTON

WHEREAS Wisconsin Statutes permit local authorities to establish speed zones within certain guidelines, and

WHEREAS a traffic engineering study has been made to determine the safe travel speed for all vehicles upon C.T.H. E in the Town of Merton.

THE COUNTY BOARD OF SUPERVISORS OF THE COUNTY OF WAUKESHA ORDAINS that the speed zone on C.T.H. E is modified as follows:


Rescind the speed limit of fifty (50) miles per hour on C.T.H. E from its intersection with Mary Hill Drive northerly to its intersection with C.T.H. VV (Silver Spring Rd).

Establish a forty five (45) mile per hour speed zone on C.T.H. E from its intersection with Mary Hill Drive northerly to its intersection with C.T.H. VV (Silver Spring Rd).

BE IT FURTHER ORDAINED that this declaration rescinds all previous restrictions for the above described portion of the County Trunk Highway System.
