

ENROLLED ORDINANCE 166-78

ADOPT POLICY THAT PROHIBITS INDIVIDUALS FROM CARRYING
CONCEALED WEAPONS IN CERTAIN COUNTY BUILDINGS
PURSUANT TO 2011 WISCONSIN ACT 35

WHEREAS, in 2011, the Wisconsin legislature enacted various changes to the Concealed Carry Law in the State of Wisconsin in Wisconsin Act 35, and

WHEREAS, Act 35 provides that counties may prohibit the carrying of concealed weapons in County owned buildings, and

WHEREAS, Waukesha County already has a zero tolerance workplace violence policy that prohibits most employees from possessing any weapon in the workplace, and

WHEREAS, the Waukesha County Code at Section 3-3 already prohibits dangerous items, as therein defined, in the Courthouse and Administration Building, and

WHEREAS, Act 35 authorizes counties to prohibit certain individuals from entering or remaining in a county owned building while carrying a firearm.

THE COUNTY BOARD OF SUPERVISORS OF THE COUNTY OF WAUKESHA ORDAINS that appropriate County officials shall take all necessary actions to notify persons carrying firearms that they cannot enter or remain in the following County buildings:


- a. Human Services Center;
- b. Public Health Center;
- c. Mental Health Center;
- d. Juvenile Center; and,
- e. Waukesha County Communications Center.


BE IT FURTHER ORDAINED that this prohibition shall not apply to individuals specifically authorized by Wisconsin law to be armed in the types of buildings listed above.


BE IT FURTHER ORDAINED that individuals or groups doing business with the County who lease or rent County facilities shall be afforded the right to set their own policy, as allowed by Wisconsin law, with regard to the leased or rented facility.
