

Sex Offender Release



The Waukesha County Sheriff's Department and the City of Waukesha Police Department have been working with the Department of Corrections-Probation and Parole Office regarding the anticipated release of KENNETH D. MCDONALD (M/W DOB 09/16/1971) to the community. McDonald will be released on Tuesday, 3/8/16. McDonald has no permanent residence at this time and upon release he will be taken to the Waukesha County Sheriff's Department for face-to-face registration. McDonald will be a lifetime sex offender registrant and also on GPS monitoring. If he violates the terms of his lifetime registry or GPS conditions, he will be taken back into custody.

McDonald is considered a serious offender with a high probability to reoffend. McDonald's conviction was in 2005 for a 2nd degree sexual assault of a child. This offense was committed against three and six year old females that were residing in the same residence as him. McDonald inappropriately touched both victims, and also admitted to being in possession of hundreds of images of child pornography. We want to make sure that the community remains vigilant and ensure they fully understand the seriousness of this offender, especially since he will not have permanent housing upon release. He will be required to make regular contact with his assigned agent, advising them of his locations. This will also be verified through the use of GPS.

With the increase in the number of homeless offenders upon release, citizens are encouraged to go to the Wisconsin Department of Corrections website for more information. This allows for searches by name and zip code, and also allows community members to sign up for email notifications. By signing up for email notifications, citizens will be provided with current residence locations of offenders. The website for DOC-Sex Offender information is:

Mr. McDonald has served the prison sentence imposed on him by the courts. **He is not wanted by the police at this time. This notification is not intended to increase fear, rather, it is our belief that an informed public is a safer public.**

Sex offenders **have always** lived in our communities; but it wasn't until Act 440 (June 1997) that law enforcement is now able to share this information with the community. Citizen abuse of this information to threaten, intimidate or harass registered sex offenders will not be tolerated. Please understand that such abuse could potentially end law enforcement's ability to do community notifications. We believe **the only person who wins if community notification ends is the sex offender**, since sex offenders derive their power through secrecy.
