- Chronic illness
- Safety issues
- Deteriorating health
- Mobility issues affecting self care
- Inability to perform activities of daily living
- Persons in need of medical or health resources
- Education about medications
- Persons physically and mentally stressed by caretaking responsibilities

### **Where do I go?**

- Adults and seniors can be seen in Public Health's Walk-In Clinic for:

- Well Child/Healthcheck Exam
- High Risk Child Services
- Lead Poisoning Prevention

### Well Child/HealthCheck Exams:

#### **What is it?**

Well child and HealthCheck screenings are complete preventive health check-up services for children. Public health nurses screen children for health concerns as well as growth and development. Referrals are made to medical providers for follow-up on areas of concern.

#### **Who is eligible?**

- **Well child exam:** Any child residing in Waukesha County is eligible for well child exams.
- **HealthCheck:** Children on Medical Assistance or Healthy Start are eligible for HealthCheck exams based on a standard schedule for age. HealthCheck exams meet the physical exam requirements for Head Start.

#### **Where do I go?**

Well child and HealthCheck screenings are offered as a Walk-In Service. HealthCheck screenings are also offered at certain WIC clinics for WIC participants.

### High Risk Child Services:

#### **What is it?**

Public health nurses provide periodic home visits to families with newborns and children with medical needs.

Services include:

- Health assessment
- Referral to community resources
- Screening for normal growth and development
- Answers to child health questions
- Case management
- Parenting and child care education

#### **Who is eligible?**

Families in Waukesha County with high-risk children, for example:

- Premature infants
- Children with medical conditions
- Issues regarding growth and development

#### **Where do I go?**

Children can be seen as a Walk-In Service or for WIC Participants at WIC clinic. For more information please call **262-896-8430**.

## LOOK OUT FOR LEAD



**M**any homes and apartments built before 1978 have lead paint or varnish on the walls, woodwork,

windows and floors. Lead can harm children. Children under six years old can easily be poisoned by dust or chips from lead paint. If they play near windows and other places with worn-out or damaged paint, they can get lead dust on their fingers and toys. When they swallow lead dust it can cause illness. It can also cause problems with learning, growth and behaviors that can affect them their entire life. Even small amounts of lead can be harmful. Children living or spending time in older homes should be tested for exposure to lead.

### Lead Screening

#### **What is it?**

- A blood test by a finger stick
- Results are provided within minutes

#### **Who is eligible?**

Any child residing in Waukesha County is eligible for a screening test.

### Lead Poisoning Care Coordination

#### **What is it?**

Public health nurses provide care coordination for children who have elevated lead levels.

#### Services include:

- Health assessment
- Growth and developmental evaluation
- Education about treatment and prevention
- Home environmental lead assessment

#### **Who is eligible?**

Any child residing in Waukesha County with an elevated blood lead level.






## COMMUNICABLE DISEASE

A communicable disease is an illness that can be transmitted from person to person, animal to person, or inanimate object to person. Examples of communicable diseases include: tuberculosis, *E. coli* O157:H7, hepatitis A, measles, and AIDS.

Reporting of communicable diseases is required by Wisconsin State Statute 252.05 and Wisconsin Administrative Code DHS 145. Individuals required to report communicable diseases include physicians, nurses, laboratory personnel, school and daycare personnel, and any others with knowledge of disease.



### Communicable Disease Follow-up:

Waukesha County Public Health Division is the agency designated by state law to receive reports of communicable disease in Waukesha County residents. Upon receipt of a communicable disease report, an investigation is conducted to determine the source of infection and to prevent further disease spread in the community.

### How are communicable diseases reported?

Communicable disease reports can be received electronically through the Wisconsin Electronic Disease Surveillance System (WEDSS), or can be phoned, faxed or mailed to the Waukesha County Public Health Division.

## Community Health Improvement Process & Plans (CHIPP)

The Community Health Improvement Plan and Process (CHIPP) is a mechanism to assess and determine the priority health needs of Waukesha County residents. In a CHIPP, "health" is defined broadly and includes physical health, mental health, environmental health and other areas that contribute to overall well-being.

The purpose of the CHIPP is to review and assess health needs from a variety of data sources and determine strengths and weaknesses. A plan is then developed to recommend strong programs in areas of need. Once a plan is developed, it is implemented and evaluated. In Wisconsin, the entire CHIPP generally spans a five year period to give enough time to observe community health improvements.

The Waukesha County CHIPP Steering Committee will provide essential leadership over the course of these five years, with a request to individual members to commit to at least two years and the opportunity to continue annually after that time.

### SEASONAL INFLUENZA (FLU) VACCINE - (EVERY ONE --- EVERY YEAR)

Waukesha County Public Health Division offers have Flu Vaccine as a [Walk-In Service](#) and at scheduled [Monthly Immunization Clinics](#) in the Community.

#### Preventing Seasonal Flu: Get Vaccinated

A flu vaccine is the FIRST and BEST step to prevent getting the flu. The flu vaccine comes as a shot or a nasal spray. Either type of flu vaccine will keep you and your loved ones safe from a very serious disease. The recommendation for flu vaccine is:

#### EVERY ONE --- EVERY YEAR

#### Flu Shot Clinics for Children & Adults

Please call ahead (262) 896-8430 to be sure the flu vaccine is available

#### Children

- The CDC recommends that children ages 6 months through 18 years of age receive a flu vaccine every year
- Bring vaccine records to clinic
- Parent or guardian must sign Public Health Division forms for children's immunizations. **If your child is insured**, please make an appointment with your primary care

provider for vaccinations. **If your child is Vaccines for Children (VFC) eligible**, you can visit the Public Health Division clinics for flu vaccinations for a fee of \$8 which can be waived if necessary.

**Who is VFC eligible?** Children through 18 years of age who are:

- ✓ **Medicaid** eligible or enrolled
- ✓ **Uninsured**
- ✓ **American Indian or Alaska Native**
- ✓ **Insured but insurance does not cover flu vaccine**

#### Adults

- The CDC recommends that all adults receive a flu vaccine every year
- For adults, the cost for flu vaccine is \$30. The cost for pneumonia vaccine is \$60
- In addition to cash and check, the Public Health Division also accepts Medicaid (Title 19) for Waukesha County residents.
- Medicare is not accepted

# FLUORIDE VARNISH FOR CHILDREN



## **What is Fluoride Varnish?**

Fluoride varnish is a protective coating that is painted on teeth to help prevent new cavities and to help stop cavities that have already started. The paint on fluoride varnish is sticky, so it attaches to the teeth easily and makes the outer layer (enamel) of the teeth harder helping to prevent cavities.

**Why is fluoride varnish recommended for children's teeth?** Tooth decay is one of the most common preventable diseases in children. Children as young as 12 to 18 months can get cavities. Cavities in children's teeth can cause pain and prevent children from eating, speaking, sleeping and learning.

**At what age should fluoride varnish be applied?** Fluoride varnish is recommended for children of all ages, including infants. Fluoride varnish is an effective replacement for weekly school fluoride mouth rinse programs.

**Is fluoride varnish safe?** Yes, fluoride varnish can be used on babies from the time they have their first teeth. Only a very small amount of fluoride varnish is used.

**How is fluoride varnish applied to the teeth?** The fluoride varnish is easily painted on the teeth with a small disposable brush. It is quick, painless, and does not have a bad taste.

**What should parents do after fluoride varnish is applied to a child's teeth?**

***Do not brush*** your child's teeth until the next day.

- Don't allow your child to eat hard or chewy foods, including gum, on the treatment day. This might chip the varnish off.
- The fluoride varnish can be yellow or clear. If the teeth appear yellow for 24 hours, this is normal, and will disappear when the teeth are brushed the next day.



**How long does fluoride varnish last?** The fluoride varnish sticks to the teeth until brushed away the next day, however, the benefits of the fluoride will last for several months.

**Who will provide this service?** A trained health professional will apply the fluoride varnish to your child's teeth.

**Who is eligible to have fluoride varnish applied?** Any child who is under age 6 and participates in Waukesha County Public Health Division's HealthCheck Program, is eligible to have fluoride varnish applied at the Public Health Division.



## IMMUNIZATION PROGRAM

Waukesha County Public Health Division provides immunizations to people of all ages. These immunizations are available at monthly clinics throughout the County or as a Walk-In Service Monday through Friday at the Public Health Division Building from 8 AM to 4 PM.

### What to Bring to Immunization Clinics

- All written immunization records must be brought to each clinic.
- The parent or legal guardian must be present or sign for children under age 18 on Public Health Division forms.

### Immunization Information

**IMMUNIZE ON SCHEDULE** — Immunizing children is one of the best ways to keep them healthy. Since childhood diseases are especially dangerous for infants, it is important to start immunizations on time, usually at birth or 2 months. Children need 80% of their vaccinations in the first 2 years of life. This usually takes 5 visits to a health care provider.

**KEEP IMMUNIZATION RECORDS** — Parents should keep their own copy of an up-to-date immunization record even though the doctors and public health clinics also keep them. Always take an up-to-date record to every doctor and public health clinic visit; records prevent unnecessary immunizations.

**THE WISCONSIN IMMUNIZATION LAW** — Wisconsin Immunization Law requires children in licensed day care centers and students through grade 12 to be immunized against certain diseases. Students must provide dates (month, date, and year) of immunization upon admission to school, or be subject to exclusion or legal action. Parents may be fined up to \$25 per day for non-compliance with the law. Waivers are available for medical, religious, or personal conviction.

Travel to a foreign country can be both exciting and challenging. The International Travel Immunization Clinic helps to plan ahead to reduce the risk of travel-related health or safety problems.

The Clinic will provide you with:

- Information about disease risks
- Information about food, water and insect precautions
- Preventive vaccines and medications

**Authorized U.S.  
Yellow Fever  
Vaccine Center**

Immunizations are provided for a fee ranging from \$20 to \$150 per vaccine, plus an office administration fee. These fees may not be waived. Payment may be by check, cash, or charge. Medicaid is accepted for residents of Waukesha County only.

### The following travel vaccines are offered:

Hepatitis A	Pneumococcal (pneumonia)
Hepatitis B	Polio
Influenza	Tetanus
Measles	Typhoid Fever
Meningitis	Yellow Fever

Also provided are the routine recommended vaccines for children and adults and prescriptions for anti-malarial drugs.

### Who is eligible?

The Clinic is open to the public.

### Where do I go?

The International Travel Clinic is held at the Public Health Center, 514 Riverview Avenue, Waukesha. **Call 262-896-8430 for an appointment.**

### **PREGNANCY TESTING**

Find out if you are pregnant through our **FREE** urine Pregnancy Test. Pregnancy is detected by measuring the concentration of human chorionic gonadotropin (hCG) in urine.

#### **Services include:**

- FREE Urine Pregnancy Test (limited to one time every 3 months. Additional tests will be \$12.00)
- Information about Family Planning and Pregnancy Prevention
- Counseling is Available
- Referrals made for Services
- Available as a **Walk-In Service**, Monday – Friday (8 AM-4 PM)
- WIC clients can get tested at your regularly scheduled appointment.

### **PRENATAL & POSTPARTUM CARE COORDINATION**

PNCC or Prenatal Care Coordination, helps women gain access to medical, social, educational, and other services during their pregnancy and 60 days postpartum. Through a series of visits, Public Health Nurses will bring you information about you and your soon-to-be baby. **Our goal is to help women have healthy babies.**

#### **Services include:**

- Health assessment
- Education about pregnancy, birth and the newborn
- Referral to community resources, including a physician for prenatal care
- Assistance with quitting smoking
- Assistance getting resources to pay for health care
- Listening and support

#### **Who is eligible?**

Pregnant Women (including but not limited to):

- High Risk Pregnancies
- First-time Moms
- Women in need of education and referral services

### **TEENS AND PREGNANCY**

Public Health Nurses provide prenatal and postpartum care coordination and education for pregnant teens in Waukesha County. Labor and delivery classes are provided to prepare teens for the delivery experience. Services are provided in the home or through the School Age Parent Program (SAPAR) Alternative Education Program.

The Waukesha County Public Health Division created an Emergency Preparedness Team in response to the events of September 11, 2001

and subsequent anthrax attacks. Public health emergency preparedness plans were expanded and enhanced to protect Waukesha County residents from bioterrorism threats, as well as from natural disasters, accidents, and infectious diseases outbreaks.

In order to have a comprehensive response to public health emergencies, the Public Health Division has collaborated and coordinated with the [Waukesha County Department of Emergency Preparedness](#), as well as, the State of Wisconsin Division of Public Health, other local health departments, area hospitals, health care providers, and community organizations. Plans have been developed to prepare for, identify, prevent, respond to, and recover from all types of public health emergencies. Public health personnel engage in on-going preparedness training including emergency response drills and exercises.

### General Preparedness Information

Waukesha County citizens share in the responsibility to be aware of and prepare for potential public health threats and emergencies. It is recommended that citizens develop a disaster plan and kit to be ready for natural health threats (such as a pandemic flu outbreak or SARS), an act of bioterrorism, an accidental release

of a chemical or other substance, or a natural disaster (such as a tornado or flood).

### Public Health Response to Outbreaks

Public health has plans to respond to infectious disease outbreaks, whether they are naturally occurring or are man-made. Examples of naturally occurring infectious disease outbreaks that cause public health concern include: pandemic influenza (H1N1 or avian/bird flu), SARS, hepatitis A, and bacterial meningitis. Examples of diseases that could be used as a bioterrorism weapon include: anthrax, smallpox and plague.

If an infectious disease outbreak threatens Waukesha County, the Public Health Division is prepared to respond by setting up mass clinics or a Point of Dispensing (POD) to dispense vaccines or medications.

In the event of a public health emergency, Waukesha County Public Health will communicate with residents in a variety of ways. Information will be on television, the radio, newspapers, special hotlines, 2-1-1, and on this website. Included will be information about the disease and its symptoms, who is at risk, where to go for preventative medication or vaccine, and where you should seek medical attention if you become ill.

## SEXUALLY TRANSMITTED DISEASE (STD) & HIV CLINICS

### **What are Sexually Transmitted Diseases?**

Sexually transmitted diseases (STD's) are diseases that can be passed from one person to another during all types of intimate sexual contact. Examples of STD's include Chlamydia, gonorrhea, herpes, HIV and syphilis; pubic lice and genital warts are also considered STD's. Symptoms of STD's may include pain while urinating, burning, itching, sores, discharge, bumps or blisters in genital area. However, a person may be infected with an STD and not have symptoms.

### **Who can Attend the STD and HIV Clinics?**

The STD clinic is available to anyone seeking confidential counseling, testing and treatment of STD's. The clinic is available by appointment only, and the fee is \$35.00. Please call the Public Health Division at (262) 896-8450 to schedule an appointment.

HIV Counseling and Testing Site Clinics are available for Waukesha County residents seeking a test for HIV, the virus that causes AIDS. The clinic is available by appointment only and the fee is \$15.00. Please call the Public Health Division at (262) 896-8450 to schedule an appointment.

This screening is only available if there are no symptoms of STDs present (see above for common symptoms). The fee is \$17, please call (262) 896-8450 with any questions.

### Waukesha County Health Report Card

The Waukesha County Health Report Card is an assessment of the county's overall health status. The Report Card is comprised of information from multiple data sources, conveniently located in one place. The fifth edition updates information on key community health status indicators for Waukesha County.

### Waukesha County Community Health Survey

In 2012, the Waukesha County Community Health Survey was commissioned by Aurora Health Care, ProHealth Care, Froedtert Health, Wheaton Franciscan Healthcare and Children's Hospital of Wisconsin in partnership with the Waukesha County Public Health Division and the Center for Urban Population Health. The purpose of this effort was to gather information on the health practices and health-related behavioral risks of residents. This research provides valuable behavioral data, lifestyle habits, and the prevalence of risk factors and disease conditions of Waukesha County residents.

### County Health Rankings

The County Health Rankings are compiled by the Robert Wood Johnson Foundation and the University of Wisconsin Population Health Institute. Each state is provided a standardized report that ranks each of its counties on health outcomes and health

### Communicable Disease Statistics

The Waukesha County Public Health Division uses a State of Wisconsin web-based system called WEDSS (Wisconsin Electronic Disease Surveillance System) to report communicable diseases. This is a real-time program which allows both Waukesha County Public Health and the State of Wisconsin to see communicable disease trends and report diseases directly to the Centers for Disease Control and Prevention (CDC).



### Other Health Statistics

From time to time, the Public Health Division receives requests for health information and statistics pertaining to communities in Waukesha County. However community-level data is not as easily obtained as county-level data. For this reason, the Public Health Division has created documents and links to websites for data pertaining to Waukesha County and the State of Wisconsin.

The Women, Infant and Children (WIC) Nutrition Program provides food and nutrition information to pregnant, postpartum, breastfeeding women, infants and children under the age of 5. In Waukesha County, WIC is administered through the Waukesha County Public Health Division.

### Participants Receive:

- Food vouchers for milk, eggs, fruits and vegetables (fresh, frozen or canned), whole wheat/whole grain foods, cereal, peanut butter, fruit juices, dried beans and peas, and infant formula, infant cereal and baby food fruit, vegetables and meats. (For WIC Approved Food Guide go to (web address above.)
- Nutrition education and information
- Breastfeeding support and counseling
- Referrals to other Public Health, community, and health services as needed.

### Who is Eligible for WIC?

- Resident of the State of Wisconsin
- Pregnant and postpartum women and children up to the age of five who are income eligible and have a health or nutrition need.
  - ♦ Income guidelines are set by the Federal Government and change each year. These guidelines are based on both the number of people in the household and the gross income amount before taxes are taken out.

**WIC Farmers Market Program** – The Wisconsin WIC Farmers’ Market Nutrition Program provides eligible WIC families vouchers to use specifically for fresh Wisconsin grown fruits, vegetables and fresh cut herbs available at local farmers’ markets. These vouchers are in addition to the regular fruit and vegetable checks issued for use in the grocery store. **WIC Farmers’ Market checks CANNOT be used in grocery stores.** Farmer’s Market Vouchers are issued one time per family, per growing season between June and September and must be spent by the end of October.
