**CERTIFICATION APPOINTMENTS**

An appointment must be scheduled to determine eligibility.

If appointment cannot be kept: Please call to reschedule as soon as possible.

**PROXY**

You may choose a responsible person who can pick up the WIC checks as well as spend them at the WIC approved stores. You may designate one or two proxies at the certification appointment. Later if you choose to add a proxy, you must write a permission note, including the date, name of the person(s) on the program, the proxy's name and your signature. The new proxy must bring this note to the WIC office along with an ID, the purple WIC folder and the WIC ID card.

**CHECK (VOUCHER) POLICY**

Always bring the WIC folder and ID card to pick up checks and when spending them at the store. If you are 15-28 days late, the food amounts will be decreased. If you are over 28 days late, no checks will be issued for that month.

Use the checks only within the specified dates printed on the checks. Checks can be used in any of the Wisconsin WIC approved stores.

In case of SEVERE WEATHER, call ahead to see if the WIC office is open. WIC will not be open if the Public Health Division is closed.
