- ◆ Spouse's Date / Place of Death *(if applicable)*



- ◆ Marriage Information: *(Current Marriages and Previous Marriages for veteran and spouse)*
 Date / Place—Current Marriage
 Date / Place—Previous Marriage
 Date / Place—Divorce/Death Previous Marriage

- ◆ Name & address of Nursing Home / Assisted Living Facility

- ◆ Bank Routing & Account Numbers
(if benefits are awarded VA will do a direct deposit)
- ◆ Marriage Certificate
(need ONLY if pension is for a widow(er))
- ◆ DD214 or Discharge Papers

- ◆ Name of person and relationship of person assisting family with Pension w/A & A
- ◆ Address / phone number of person assisting family

- ◆ Title 19 verification or Family Care
(if available)
- ◆ All out of pocket medical costs: *(Nursing Home / Assisted Living, Medical Insurance)*
- ◆ All asset information: *(CD's, IRA's, Money Markets, Stocks/Bonds, Property [not their primary home] Checking/Saving Accounts)*
- ◆ Amount of all income including any pensions or any other income: *(IRA disbursements are considered income)*

Non-Service Connected Pension

NON-SERVICE CONNECTED PENSION HAS THREE COMPONENTS TO IT

1. Regular Pension:
Requires low income and a disability.
2. Pension with Homebound Status:
Requires a disability that is such that the veteran is substantially confined to his home and needs assistance with daily living.
3. Pension with Aid and Attendance:
Veteran resides in a Nursing Home, Group Home, CBRF, Assisted Living or resides in his/her home and the veteran is substantially confined to his/her home and needs assistance with daily living.

ELIGIBILITY

- ◆ Honorable Discharge
 - ◆ 90 Days of Active Duty Service
 - ◆ 1 Day During a War Period
 - * Age 65 and older
 - ◆ Countable Household Income Below Limits Set by Law
- ◆ **SEE NOTE:**

SURVIVING SPOUSE ENTITLEMENT

Un-remarried surviving spouses that may have eligibility if he/she has:

- ◆ Homebound Status
- ◆ Aid and Attendance of Another Person
- ◆ Living in an Assisted Living Facility
- ◆ Living in a Nursing Home and/or CBRF
- ◆ Living in a Group Home
- ◆ Resides in his/her home and is substantially confined to his/her home and needs assistance with daily living.

UN-REIMBURSED MEDICAL EXPENSES

Payment may be increased if the recipient has un-reimbursed medical expenses that can be deducted from countable income.

NOTE:

- ◆ a veteran who entered active duty on or after September 8, 1980, or officers who entered active duty on or after October 16, 1981, may have to meet a longer minimum period of active duty
- * If the veteran is under age 65 and is permanently and Totally Disabled he/she may be eligible.
