1. Call to Order

The meeting was called to order by Matt Redmann at 1:33 p.m.

2. Meeting Location Specific Instructions for Emergency Evacuation or Shelter in Place

Bill Stolte delivered emergency instructions for this location at the Waukesha County Highway Operations Building at 1641 Woodburn Road in Waukesha.

3. Approval of Minutes of March 16, 2016 Meeting

The minutes of the March 16 meeting were approved. **Motion by Steve Kay, second by Bill Stolte to approve the minutes. All members present voting AYE, motion carried.**

4. Welcome New Members

The Committee welcomed new members Tony Feck and Sherri Stigler, and everyone introduced themselves.

5. Public Comment

Jim Batzko reported that the Waukesha County Board of Supervisors formally approved the Waukesha County Hazard Mitigation Plan at its meeting the previous night, July 26.

6. Elect Vice Chairperson

With no other nominations, Steve Kay nominated himself as Vice Chairperson. **Motion by Matt Redmann, second by Bill Stolte to close nominations and elect Steve Kay as Vice Chairperson by unanimous acclamation. All members present voting AYE, motion carried.**

7. Invoice Review – Discussion and Action

Kathy Schwei reported on a suspected drug lab incident in Sussex on April 11. Sussex Fire Department requested the City of Waukesha Hazmat Team to respond to an incident at N58W23987 Hastings Ct. in Sussex due to some suspicious items in a garage. The Hazmat Team responded and performed monitoring and sampling to determine the chemicals present. The Department of Justice was also present. Further investigation revealed that there was not a drug lab on site, but rather parts of a hydrogen generator. At the time of the incident, the condo and garage were owned by the U.S. Department of Housing and Urban Development. Waukesha County Emergency Management sent an invoice to HUD for the costs associated with the response by the Hazmat Team. The County has not received a response at this time.

Stolte expects that Waukesha County Emergency Management will receive an invoice for costs associated with a diesel spill incident on July 25 that involved a truck leaking diesel fuel for a relatively long distance through the City of Waukesha. When received, the invoice will be forwarded to the trucking company.

Exercises:

- Cities Readiness Initiative 2016 Exercise – Ben Jones noted that this was the culmination of several years of exercising. Waukesha County opened a mass clinic and had a full activation of the Emergency Operations Center. GE Healthcare opened a closed pod for distribution of medications to their employees. Twelve pods were opened in the SE region in this exercise. This was one of the largest CRI exercises in the nation.

11. Member Reports

Ben Jones reported on the concern across the nation over the Zika virus. There were 11 travel related cases of people infected with the Zika virus in Wisconsin, but no mosquitos carrying Zika have been discovered in WI through monitoring and sampling efforts. He also reported that the Centers for Disease Control sent a behavioralist to WI to study an outbreak of Elizabethkingia, but the source of the outbreak was not discovered. He also reported that the Healthcare Emergency Readiness Coalition (HERC) in SE Wisconsin adopted new bylaws on July 26 and that Ben Jones is the Caucus Leader of the Public Health Caucus, and Ben Schliesman is the Caucus Leader of the Emergency Management Caucus. Each HERC has representatives from eight caucuses that comprise their membership.
