APPROVAL OF MINUTES

UNMET NEEDS

The committee discussed the need for an ambulatory detox, as well as detox facilities within the county.

John Kettler commented that the Mental Health Advisory Committee (MHAC) renamed "Unmet Needs" to "Prioritized Community Needs" to refocus the thought process of the members and the board, as we are not necessarily looking at those needs that do not exist, but rather putting a priority on those needs that either do or do not exist. Also, the

funding for the Independent Living Specialist will be taken off of the joint presentation list because the ADRC has a staff person that can handle these needs.

Sternweis commented that the MHAC Board Liaison had mentioned that the board wants to see the funding priorities.

The list of prioritized community needs that will be presented to the board on behalf of the AODA Advisory Committee are:

1. Mobile or Ambulatory Detox
2. Ongoing Needs for Vivitrol
3. Addiction-ologist
4. Education for Aging Population
5. (Honorable Mention) Education for Schools (and Parents) for Returning and Transitioning Students

UPCOMING EVENT

Marty Calderon introduced Milwaukee County Supervisor Peggy West. West commented that there is a Facebook page (MKE Heroin Diaries) for people to share their stories. There will also be a march from 1-3pm on Saturday, March 4th. The route is currently still being finalized, but the end will be at the 2nd district police station with featured speakers and a call to action.

HHS STAFF LIAISON REPORT

Kettler reported that About Health held an opiate collaborative bringing together multiple hospitals of care.

The HHS Board and Committee approved accepting the PDO grant monies at a combined meeting last week.
